3.	To maintain a Renters' Insurance policy with personal liability coverage of no less than \$100,000. If tenant fails to maintain this coverage and/or provide proof of said coverage, Owner/Agent is authorized to obtain and pay for said coverage on behalf of the Renter and add the policy premium plus \$5.00 per month to the Renter's monthly rent.								
4.	To keep the animal from causing any annoyance or discomfort to others and to immediately remedy any complaints concerning the animal.								
5.	To keep the animal from damaging any property belonging to the Owner/Agent or others.								
6.	To immediately pay for any injury, damage, loss, or expense caused by the animal (In this regard, it is expressly understood that at no time shall the Renter apply any part of the Security Deposit towards such amounts due, but rather, the Renter shall make restitution immediately and separately from the deposit. It is further understood that such restitution shall be made over and above any additional rent paid in accordance with Item #1 of this Agreement.)								
7.	To keep the animal under control at all times.								
8.	To keep the animal restrained, but not tethered, when it is outside of the dwelling.								
9.	Not to leave the animal unattended for any unreasonable period.								
10.	To hold the Owner/Agent harmless from all liabilityarising from the Renter's ownership or keeping of the animal, including but not limited to any liability resulting from the Owner/Agent turning said animal over to local animal control authorities should the animal be found unsupervised.								
11.	To dispose of the animal's droppings properly and promptly. Animal droppings must be picked up and disposed of immediately.								
12.	If any animal is a dog, the Renter agrees to be responsible for grass cutting, either performing the grass cutting himself/herself or by arranging for and paying for a lawn service. Renter agrees that grass will not be allowed to grow to a height greater than 4 inches. Failure to maintain the grass according to these standards will result in an additional \$ charge per grass cutting procured or performed by Owner/Agent.								
13.	To provide to the Owner/Agent a picture(s) of the listed animal(s).								
	To insure that the animal will wear the appropriate Local Animal License, a valid Rabies Tag (if a dog) and tag bearing the owners name and phone number. All licenses and tags must be kept current.								
15.	To provide the Owner/Agent with evidence from the Veterinarian that all necessary shots are current and that the animal does not display a tendency to be aggressive or harmful. Owner/Agent will be provided annual proof, prior to and within 60 to 90 days of lease renewal date, of animal's licensing and shots.								
16.	Renter agrees to control flea infestation and will exterminate if necessary, and upon demand, in any and all areas affected with full cost to be paid by Renter.								
	Renter agrees that Owner/Agent will not be responsible for the injury, harm, or death of the animal, and agrees to hold Owner/Agent harmless for any damages suffered as a result of any harm caused on the animal or by the animal upon another person, guest or employee. Renter shall be responsible for the entire amount of all damages caused by the animal as well as the entire amount of any injury to individuals or property. Expermission granted herein shall be limited to the pets listed below:
